Stokesley Town Council carried out public consultation through our website and through our Newsletter which appears in the 'Market Place' magazine and is circulated to every household in Stokesley.

The consultation confirmed that the Public Toilets were identified as one of the top priorities along with improvements to the Levenside. New Christmas Lights were second and the installation of a CCTV camera in the North Road Play Park as third. We have successfully completed the Public Toilet refurbishment project and purchased new lights for the Town as a phase 1 development this year. In addition, the Town Council took the decision to repair the benches across the Town, in particular the High Street to try and support the Vibrant Market Towns initiative.

Future projects include Christmas Lights Phase 2 – which will complete this project and we aim to do this in 2019/20. We are in the process of consulting about the installation of a CCTV system in the North Road Play area – and it is hoped that the Town Council will fund the camera and routine maintenance, but it will be managed by HDC. Initial discussions regarding the Levenside Project have commenced with the Environment Agency as the first stage will see repairs to the river wall which will then enable us to improve the public footpath. This scheme will only be achievable if we are successful in securing grants from other providers, something we are currently reviewing.
