2. Nomination papers must be HAND delivered to the Returning Officer, (Room 220) at Hambleton District Council, Civic Centre, Stone Cross, Northallerton DL6 2UU between 10am and 4pm on any working day from the day after the date of this notice, but no later than 4pm on Wednesday 3 April.
3. If any election is contested the poll will take place on Thursday 2 May.
4. Applications to register to vote must reach the Electoral Registration Officer by midnight on Friday 12 April. Applications can be made online: [www.gov.uk/register-to-vote](http://www.gov.uk/register-to-vote)
5. Applications, amendments or cancellations of postal votes must reach the Electoral Registration Officer at the address below by 5pm on Monday 15 April.
6. Applications to vote by proxy at this election must reach the Electoral Registration Officer at at the address below by 5pm on Wednesday 24 April.
7. Applications to vote by emergency proxy at this election on grounds of physical incapacity or for work/service reasons must reach the Electoral Registration Officer at the address below by 5pm on Thursday 2 May. The physical incapacity must have occurred after 5pm on Wednesday 24 April. To apply on the grounds of work/service, the person must have become aware that they cannot go to the polling station in person after 5pm on Wednesday 24 April.
